

Upon the March 5, 2019 affirmation of John Pearson Kelly, the March 5, 2019 affidavit of Gail Pierce-Siponen (“Pierce-Siponen Affidavit”) and the exhibits attached thereto, submitted in support of the *ex parte* motion of Linda A. Lacewell, Acting Superintendent of Financial Services in her capacity as Liquidator of Health Republic Insurance of New York, Corp. (“Health Republic”) to approve the Liquidator’s recommended determinations of policy claims as reflected in Explanation of Benefits (“EOB”) forms sent to Health Republic claimants in accordance with the claims Adjudication Procedure approved by the Court, including both allowances and disallowances of claims as reflected in the EOBs (“Motion”);


NOW, after due deliberation having been had, it is

are hereby approved, and claims recommended for disallowance and shown as 0 dollars are hereby disallowed, and claims recommended for allowance are hereby allowed in the amounts shown, in the total amount of \$217,955,319.63, as Class two claims in the Health Republic estate pursuant to Section 7434 of the New York Insurance Law.
