Vullo, Superintendent of Financial Services of the State of New York as liquidator ("Liquidator") of Health Republic Insurance of New York, Corp. ("Health Republic"), dated January 20, 2017, and upon all other papers previously submitted and all proceedings heretofore had herein;

NOW, on motion of the Liquidator, and after due deliberation having been had thereon;

("Return Date"), or as soon thereafter as counsel can be heard, why an order, substantially in the form of the proposed order attached as Exhibit D to the Kirshnitz Affirmation, should not be made confirming that, notwithstanding the existence of an anti-assignment provision in a Health Republic insurance policy, the Liquidator may, where appropriate, make an allowed payment

directly to a health care provider for the costs of covered services, whether the claim for payment was made by the policyholder, the health care provider, or both;

AND, sufficient cause having been alleged therefore, it is hereby

ORDERED, that the Liquidator shall give notice of this application by: (i) posting this Order to Show Cause and its supporting papers on the Health Republic Internet web page at http://www.healthrepublicny.org/ and the New York Liquidation Bureau Internet web page at http://www.nylb.org/ at least ten (10) days before the Return Date; and (ii) publishing the notice substantially in the form attached as Exhibit C to the Kirshnitz Affirmation in the New York Post and the New York Daily News within twenty (20) days following the date of issuance of this Order to Show Cause; and it is further

ORDERED, that a copy of answering papers, either in support of or opposition to the relief sought herein ("Answering Papers"), shall be served on the Liquidator at the following address:
